

NOTICE OF HEARING

DISSOLUTION OF THE HAVEN SANITARY DISTRICT

WHEREAS, owners of land within the Haven Sanitary District have filed with the Town Clerk a Petition requesting that the Town Board of the Town of Mosel dissolve the Haven Sanitary District pursuant to Wis. Stat. §§ 60.785(3) and 60.71; and

WHEREAS, the current boundaries of the Haven Sanitary District are legally described as commencing in the South line of County Truck Highway “A”, (in the Northeast Quarter (NE-1/4) of the Northeast Quarter (NE-1/4) of Section Twenty-one (21), Town Sixteen (16) North, Range Twenty-three (23) East), Eight hundred two and Five tenths (802.5) feet East of its intersection with the East right-of-way line of the Chicago and Northwestern Railroad, thence South Two hundred sixty-four (264) feet, thence West Five hundred sixty-nine and Five tenths (569.5) feet, thence South Two hundred sixty (260) feet, thence West Three hundred sixty-seven (367) feet to the West right-of-way line of the Chicago and Northwestern Railroad, thence North along said right-of-way Two hundred eighty-four and Seventy-five hundredths (284.75) feet, thence West Five hundred sixty-four and Seventy-five hundredths (564.75) feet, thence North Two hundred eighty-eight and Seventy-five hundredths (288.75) feet to the North right-of-way line of County Truck Highway “A”, thence East Ninety-nine and Seventy-five hundredths (99.75) feet, thence North Two hundred sixty-four (264) feet, thence East Five hundred sixty-four (264) feet, thence East Five hundred sixty-four (564) feet to the East right-of-way line of the Chicago and Northwestern Railroad, thence South Forty-four (44) feet, thence West Two hundred eighty-seven (287) feet, thence South Two hundred forty-four and Seventy-five hundredths (244.75) feet to the North line of County Truck Highway “A”, thence East along said line Five hundred fifteen and Five tenths (515.5) feet, thence South Forty-nine and Five tenths (49.5) feet to the point of beginning, being part of Sections Sixteen (16) and Twenty-one (21), in the Town of Mosel, (Town Sixteen (16) North, Range Twenty-three (23) East), Sheboygan County, Wisconsin.
