

**TOWN OF MOSEL  
PUBLIC HEARING ON THE 2011 BUDGET AND  
SPECIAL TOWN MEETING**

**NOVEMBER 11, 2010**

**MINUTES**

- I. Call To Order and Verification of Meeting Duly Noticed.** Town Chair Dirk Zylman called the meeting to order at 7:00 p.m. at the Mosel Town Hall, W982 County Road FF, Sheboygan. Also present were Supervisors Wayne Warnecke and Dave Scharinger, Clerk-Treasurer Rachel Rehbein, and town residents Sue Zylman, Gail Warnecke, Mike & Kenlyn Langland. Clerk-Treasurer Rehbein confirmed the notice of hearing was properly noticed on October 21, 2010 at the Town Hall at 8:22 a.m., the Transfer Station at 8:27 a.m., Joe's Hometown Auto at 8:36 a.m., the website on October 18, 2010 at 2:50 p.m., and published in the paper October 21, 2010. The agenda was posted November 10, 2010 at the Town Hall at 11:23 a.m., the Transfer Station at 11:28 a.m., Joe's Hometown Auto at 11:36 a.m., and the website at 12:20 p.m.
- II. Pledge of Allegiance.** All present stood and recited the Pledge of Allegiance.
- III. Town of Mosel 2011 Budget.**
- A. Presentation of 2011 Budget.** Chair Zylman reviewed the proposed 2011 budget revenues and expenditures. The levy will be down slightly from 2010. Because the Whistling Straits Golf Course assessment was reduced as a result of a successful challenge, overall property values in the town were down. This will mean that individual tax bills may be higher.
- B. Open Floor for Public Testimony/Comments.** Several questions were asked by those present and answered by the Board.
- C. Close Floor to Public Testimony/Comments.** There being no further comments, Chair Zylman closed the floor to public testimony on the 2011 budget.
- IV. Elector Action.**
- A. Approve total 2011 highway expenditures, pursuant to Sec. 82.03, Wis. Stats. Motion Kenlyn Langland/Mike Langland to approve total 2011 highway expenditures not to exceed \$150,000; motion carried 8-0.**
- B. Adopt 2010 town tax levy to be paid in 2011, pursuant to Sec. 60.10(1)(a), Wis. Stats. Motion Mike Langland/Kenlyn Langland to set the 2010 town tax levy to be paid in 2011 at \$177,462.00; motion carried 8-0.**
- C. Discuss/Establish salaries of elected town officials for terms beginning in April 2011, pursuant to Sec. 60.10(b) and Sec. 60.32, Wis. Stats.** The Town Board recommended an increase in the Town Constable salary from \$2,000.00 to \$2,200.00. Motion Sue Zylman/Gail Warnecke to increase the Town Constable salary to \$2,200.00; motion carried 8-0.
- V. Adjourn. Motion Kenlyn Langland/Mike Langland to adjourn; motion carried 8-0.** Meeting adjourned at 7:52 p.m.
