

**TOWN OF MOSEL
PUBLIC HEARING ON THE 2012 BUDGET AND
SPECIAL TOWN MEETING**

MINUTES

- I. Call To Order and Verification of Meeting Duly Noticed.** Town Chair Dirk Zylman called the meeting to order at 7:00 p.m. at the Mosel Town Hall, W982 County Road FF, Sheboygan. Also present were Supervisors Wayne Warnecke and Aaron Anger, Clerk-Treasurer Rachel Rehbein, and town residents Wayne Grunwald, Kenneth Dirks, Kenlyn & Mike Langland, Warren Wunsch, Susan Zylman, and Barb Bitter. Clerk-Treasurer Rehbein confirmed the notice of hearing was properly noticed on October 31, 2011 at the Town Hall at 3:06 p.m., the Transfer Station at 3:15 p.m., Joe's Hometown Auto at 3:24 p.m., the website at 9:46 a.m., and published in the paper November 1, 2011. The agenda was posted November 14, 2011 at the Town Hall at 2:56 p.m., the Transfer Station at 3:09 p.m., Joe's Hometown Auto at 3:17 p.m., and the website at 2:04 p.m.
- II. Pledge of Allegiance.** All present stood and recited the Pledge of Allegiance.
- III. Review 2011 Budget Actual.** Clerk-Treasurer Rehbein reviewed the 2011 budget actual revenue and expenditures.
- IV. Presentation of 2012 Budget.** Chair Zylman reviewed the proposed 2012 budget revenues and expenditures. The levy will be the same as 2011.
 - A. Open Floor for Public Testimony/Comments.** Questions were asked by those present and answered by the Board.
 - B. Close Floor to Public Testimony/Comments.** There being no further comments, Chair Zylman closed the floor to public testimony on the 2012 budget.

 - A. Approve total 2012 highway expenditures, pursuant to Sec. 82.03, Wis. Stats.** Motion Mike Langland/Kenneth Dirks to approve total 2012 highway expenditures not to exceed \$150,000; motion carried 11-0.
 - B. Adopt 2011 town tax levy to be paid in 2012, pursuant to Sec. 60.10(1)(a), Wis. Stats.** Motion Barb Bitter/Kenlyn Langland to set the 2011 town tax levy to be paid in 2012 at \$177,462.00; motion carried 11-0.
- VI. Adjourn.** Motion Kenneth Dirks/Wayne Grunwald to adjourn; motion carried 11-0.
